# OCTOBER 7, 2025 GARRETT COMMON COUNCIL GARRETT, INDIANA 46738

Meeting opened with the Pledge to the Flag and called to order at 7:00pm; Garrett City Hall Council Chambers by the Chair Mayor Todd A. Fiandt.

Members present – Toby Jordan, Amanda Charles, Bobby Diederich and Brian Best / Absent – Dave Demske Also, present – Clerk Treasurer Marcie Conkle, City Attorney Chad Rayle, Police Chief Gerald Kline, Fire Chief Doug Castator and City Planner Madalyn Sade-Bartl.

MOTION BEST TO APPROVE WITH PREVIOUS MINUTES FROM SEPTEMBER 16, 2025, SECOND DIEDERICH – UNANIMOUS.

#### **CITIZENS / PETITION REPORTS:**

Dave Vanderbosch – Electric Superintendent

No intent to be disrespectful. Discussion of previous meetings mentioning Electric wages as well as previous administration and wages for electric and no follow through on those wage increases. Best asked about wage study by Scott Bowles and encouraged us to use study. Vanderbosch stated it's difficult to hire today, and we do not offer contract wages. My fear is we're going to lose employees. I have been with the city for 42 years and have devoted 40 years to the Fire Department. I hope you take this in consideration. Further discussion held.

Mayor, Thank you Dave for your years of service and to all the electric department. Mayor again read other areas on lineman wages. Anywhere from \$32 to \$40 +

Hiring for all departments are hard. When people have left it was because of voluntary termination. Mayor also contacted Cities on AIM salary studies for wages and other cities use AIM salary studies as well.

Brian Best – value the Electric Department, you do dangerous work and I thank you. Council can decrease but not increase. I support/encourage Mayor and Electric to continue discussion and present if needed following statue deadlines. Council can reduce wage ordinance but they cannot increase. I'm committed to fairness, encourage unbiased study. When did the Mayor and Dave sit down and discuss this? We did not said Vanderbosch.

Jordan and Charles – both agreed that wages need to be looked at sooner.

Council has the authority of Police / Fire Wages. Diederich – I have a problem with giving across the board raises. Contract work, electric is falling behind.

Joe Henderson – Thank you to the Electric Department, I appreciate you guys. Had a dispute in his front yard and talked to the Mayor and Chief on what happened. Public Police Complaint form. Had a kid come out with brass knuckles and threatened me. Officers did nothing about it. Ex-wife hit him with her car and police never did anything there as well. Captain Pepple said it's a mutual intimidation. Asked to speak with Chief Kline and I was denied. The 2<sup>nd</sup> time I called police they refused to do anything. This fella had other complaints on him.

How many complaints have we seen? Police are not doing their jobs. What is it going to take? Chief Kline took statement and protective order but have to get report from Chief first. Jordan asked what was the time line on this? 2 days per Joe. Pepple did not tell Chief. Had to take time off of work. Who sees these complaints? Just the Chief per Kline. Mayor sent videos to other officers. Jordan asked if a report was made? It's being done now per Chief. Discussion was held. Diederich asked if Joe could take it to the county himself? Officers have to be the one to send to the prosecutor. No statement and did not get Chief when I asked for him. Police said not enough evidence and did not do a report. Joe directed questions to the Council on what is the policy on taking statements? Depends on the situation, per Kline. Jordan stated that he believes Chief Kline is trying to do what's best for the city.

Daniel Rhoades – Over summer notice sidewalks on 100 block by the VFW is falling apart. City Planner Madalyn will have 50/50 project for next year. It's still up to the property owner to take care of the sidewalk.

Matt Hartman – Things to think about. Also discuss issues with wages. Dave 42 years and myself 27 years. Need to retain our employees. If I have to go back and be on call every other week, I will leave. Utilities in Auburn pay \$17.00 more.
